## CONSENT TO REMOVE COIN(S) FROM HOLDER(S)

4. I understand that if the submitted coin(s) are determined by NGC to be Not Genuine, Questionable Authenticity or Authenticity Unverifiable, the coin(s) will be labeled as such and will not be graded or encapsulated.
5. I understand that NGC will use due care in removing the coin(s) from the holder(s), but agree that NGC will not have any liability for damage to the coin(s) in connection with this removal.
6. I understand that the Services Terms and Conditions on the NGC Submission Form apply to this coin submission as well. If there is a conflict between this Consent and the Services Terms and Conditions, then this Consent will control.
